**Dacus Report/Legal Edge**- Truth Network via FTP or Dropbox, Weekly, :60, 30 second and weekly 26min Long Format

**Patriot & Preacher**- Truth Network via FTP or Dropbox, Weekly 55 min

1. Station agrees to broadcast the program in its entirety without deletion.

2. Station may terminate this agreement by giving Truth 30 days prior written notice of termination. Truth may terminate this agreement at any time and for any reason upon 30 days prior written notice to Station.

3. Delivery method for Programs shall be by satellite or file – listed above. Station shall have sole responsibility for construction, installation; operation and maintenance of all facilities necessary to receive and broadcast the show as distributed by Truth/Xtremedia including satellite receivers. Station shall provide its own receiver and /or any cards necessary to receive Programs.

4. This Agreement shall be interpreted and construed in accordance with the laws of the State of North Carolina.

5. This Agreement constitutes the entire agreement. Agreement cannot be changed or terminated orally and no changes, amendments or assignment hereof shall be binding upon Truth until accepted in writing by duly authorized agent.

6. The person signing this Agreement in the name and on behalf of Broadcaster, and the person signing this Agreement in the name and on behalf of Truth, each certifies that he/she is fully authorized to do so.

7. Station is granted exclusive rights to broadcast show in the metropolitan area, if at least metropolitan area is covered by Secondary coverage area, according to Radio Locator.

8. Rights/Interests. All rights, title, and interest in programming (other than public domain material) shall be/remain vested in Truth/Xtremedia exclusively.

9. Force Majeure. Neither party shall be responsible for damages suffered by the other party due to any interruption in its services hereunder by means of any act of God, labor dispute, nondelivery by program suppliers or others, failure or breakdown of satellite or other facilities, legal enactment, governmental order or regulation or any other similar or dissimilar cause beyond the control of such party, as the case may be.
